

# Norm Mowles update:

We sold 27 booths to member's totalling \$675 (NOTE: We still have 10 members who have NOT paid)

Sold 140 to non members totalling \$4200

100 tables @\$15 totalling \$1500.00

32 chairs @ \$5 totalling \$160.00

Total raised from vendors \$6535.00

Basic Hall rental is \$5300.00 then once you pay for security, tables, and maintenance usually around \$6300.00 So vendors now should cover all expenses of Hall.

Last year we had 2043 people come through the door totalling \$10,215.

Hopefully we will have the same again this year as we have been sold out since end of October.

We did have couple cancellations but were filled immediately from cancellation list.

We are estimating total before expenses to be \$17,000.00

But we are doing it differently this year as we are trying to get majority of the setup done on Friday, so please volunteer to give us a hand on Friday afternoon as well as Saturday let's make this a huge success
